

Dependency Status Appeal Process

For the 2024-2025 academic year, you're automatically considered an independent student IF at least one of the following applies to you:

- You were born before January 1, 2001
- You're married on the day you apply (even if you are separated but not divorced).
- You are or will be enrolled in a master's or doctoral degree program (beyond a bachelor's degree) at the beginning of the 2024-2025 academic year.
- You are currently serving on active duty in the U.S. Armed Forces for purposes other than training.
- You're a veteran of the U.S. Armed Forces. (A "veteran" includes students who attended a U.S. service academy and were released under a condition other than dishonorable. For more details on who is considered a veteran, see the explanatory notes on the FAFSA.)
- You have children who will receive more than half their support from you between July 1, 2024 and June 30, 2025.
- You have legal dependents (other than your children or spouse) who live with you and who receive more than half their support from you now and through June 30, 2025.
- At any time since you turned 13, both of your parents deceased, you were in foster care, or you were a dependent or ward of the court.
- As of the day you apply for aid, you are an emancipated minor as determined by a court in your state of legal residence.
- As of the day you apply for aid, you are in legal guardianship as determined by a court in your state of legal residence.
- At any time on or after July 1, 2023, your high school or school district homeless liaison determined that you were an unaccompanied youth who was homeless.
- At any time on or after July 1, 2023, the director of an emergency shelter program funded by the U.S. Department of Housing and Urban Development determined that you were an unaccompanied youth who was homeless.
- At any time on or after July 1, 2023 the director of a runaway or homeless youth basic center or transitional living program determined that
 you were an unaccompanied youth who was homeless or were self-supporting and at risk of beinghomeless.

If none of these criteria apply to you, you are a dependent student. Unless you meet one of these criteria for independent status for financial aid, then your parent(s) must complete the FAFSA with your parents' information. Your parent(s) must provide income and asset information on the FAFSA.

Appeals to Dependency Status

You may submit an appeal if an unusual, mitigating circumstance exists. It must be based on an unusual situation. Some reasons for an appeal to your dependency status are listed below.

NOTE: The unwillingness of a parent to contribute to the student's educational cost or to complete the FAFSA does not warrant a dependency override. In addition, a student living independent of any parental support does not affect the student's dependency status. Neither of these circumstances is considered unusual or mitigating.

Possible mitigating circumstances include the following:

- Your parent(s) are incarcerated.
- 2. Your parent(s) live in a war-torn country, and you are unable to communicate/correspond with them.
- 3. Your parent(s) is/are mentally incapacitated.
- 4. You are estranged from your parent(s) because of an abusive situation.

Instructions for Preparing an Appeal

- 1. Provide a reason for your dependency appeal on the attached form.
- 2. Provide documentation to support your reason. This should be from an unrelated third party, such as a counselor, social worker, doctor, or the court system. (Please provide at least three separate forms of documentation.)
- 3. Complete the income and expense information on the attached form.

You will be notified of the decision after your appeal has been reviewed. The Financial Aid Office may request additional information from you before making a decision.
